And some security forces elements that particularly in the Philippines National Police practiced extrajudicial killings, vigilantism, disappearance, torture and arbitrary arrest and detention to their battle against criminals and terrorists. Prison conditions were harsh, and the slow judicial process and the needs of law. Besides criminals and terrorists. Human right activities, atheists and agnostics, left wing, policies activities, and muslin were sometimes the victims of improper police conduct. And there is violence against women and abuse of children remained serious problems, and some children were pressed into slave labor and prostitution.

There are human right watch writers that the murders and kidnapping are rarely investigated by the police or other government agencies; they often do unreport because of fears by reprisal against the victims their families. And the PNP Philippines National Police blame investigation failures on their reluctance because to follow up the cases they didn't mind that there are families that need a justice. And witnesses are indeed reluctant to cooperation with police investigations, because of fear that they would be targeted by doing so. An extremely weak witness protection program exacerbates these problems. Police are often to having a serious investigation cases that they pass to the other agencies like **AFP**. The families told that human rights are not apply and when they repentant relevant cases to the police, and police often demanded that the families themselves produce evidence and witnesses. Even when police field cases with a court, they often that identified the perpetrators either as long wanted member of the **NPA** or simply as **JOHN DOE**. Some families told human rights watch that police gave up investigation after only a few days. Many cases that they didn't discover what the reason why is crime happened is. Even in a murder, raped, homicide and violence agents women. And the peace and human right is also didn't apply in the women.

Violence against women refers to all forms of violence inflicted on women on account of their gender. In the broadest sense, it is a violation of woman's personhood, mental or physical integrity to freedom of moment. The rise in the reported incidents heightens the need for the government. All sectors concerned to take urgent moves to the issue. Many agencies having a paper that includes data on different violence against children. Children have a human right to live and to give them life. Children's rights are the human rights of children with particular attention to the rights of special protection and care afforded to the young, including their right to association with both biological parents, human identity as well as the basic needs for food, universal state-paid education, health care and criminal laws appropriate for the age and development of the child. Interpretations of children's rights range from allowing children the capacity for autonomous action to the enforcement of children being physically, mentally and emotionally free from abuse, though what constitutes "abuse" is a matter of debate. Other definitions include the rights to care and nurturing.

A child is any human being below the age of eighteen years, unless under the law applicable to the child, majority is attained earlier." According to Cornell University, a child is a person, not a subperson, and the parent has absolute interest and possession of the child, but this is very much an American view. The term "child" does not necessarily

mean minor but can include adult children as well as adult nondependent children. There are no definitions of other terms used to describe young people such as "adolescents", "teenagers," or "youth" in international law, but the children's rights movement is considered distinct from the youth rights movement..

A peace movement is a social movement that seeks to achieve ideals such as the ending of a particular war (or all wars), minimize inter-human violence in a particular place or type of situation, often linked to the goal of achieving world peace. Means to achieve these ends usually include advocacy of pacifism, non-violent resistance, diplomacy, boycotts, moral purchasing, supporting anti-war political candidates, demonstrations, and lobbying to create legislation.
